

Completeness Check for Belize RPP dated March, 2015

FCPF Facility Management Team, March 4th, 2015

Background:

Belize submitted a Readiness Preparation Proposal (R-PP) to the Facility Management Team (FMT) in July 2013, in accordance with Resolution PC/14/2013/2, and the R-PP was reviewed by a Technical Advisory Panel (TAP), and a working group consisting of PC members established for this purpose;

At the sixteenth PC Meeting, Belize presented its R-PP and was encouraged to resubmit its R-PP for formal assessment and consideration for selection at the seventeenth PC Meeting;

Belize subsequently revised its R-PP, taking into account the issues that were identified in the R-PP assessments by the TAP and the PC working group, as well as those raised by the PC, as summarized in the Co-Chairs' Summary for the sixteenth PC Meeting. The revised R-PP was reviewed by a TAP and a working group consisting of the PC members established for this purpose, and was presented at the seventeenth PC Meeting on July 2-4, 2014 in Lima, Peru.

At this meeting, the PC adopted PC resolution PC/17/2014/8 deciding to allocate funding to enable Belize to move ahead with REDD+ readiness preparation.

Belize submitted a final revised R-PP to the FCPF FMT on March 4th, 2015. Completeness check by the FMT is formally required in the above-mentioned PC resolution.

The table below presents the results of the completeness check per issue raised in the Resolution.

This Protocol follows the principles of FPIC and has been tailored to the Belize situation and approved by village Alcaldes. During the Readiness phase, the document reads, consultations with IPs will focus on REDD+ strategies that are in harmony

The description is a historical summary from 1995 to 2015 of the lawsuits and decisions on different courts providing a good picture of the discussions that have taken place so far. The R-PP states that among others "in consideration of Belize's participation in the Agreement Establishing the Caribbean Court of Justice it is the opinion of the Solicitor General's chamber that Belize is legally obligated both in complying and enforcing all decisions and orders from the appellate jurisdiction of the Caribbean Court of Justice."

	It also recalls on an IDB Land Administration Project and other projects that will be linked to the SESA process. The budget on section 2 d was updated with an addition of US\$ 20 thousand to include the Risk Assessment of Land Tenure in Belize, completing the recommendations from the PC successfully.	
4. Include a roadmap for the development of a Reference Level that reflects the main anthropogenic and natural drivers of deforestation and forest degradation.	On Component 3 a Roadmap on a table form was added to explain the development of the reference level for deforestation and forest degradation that reflects how the anthropogenic and natural drivers will be dealt with. The road map shows how the Reference Level for Historic Cover trends and six of the main anthropogenic drivers of deforestation are connected to the type of available data, the methodology to gather the information needed for the reference level and the	Item completed.

5. Describe the relationships between sub-component 4a. on MRV and sub-components 2a. and 2b.	Under Component 6 a supplementary section linking MRV to performance of REDD+ Strategy was added. This section indicates that the results of monitoring will inform whether modifications to strategy options are necessary. A new table is presented describing how MRV systems will address the different drivers in order to inform whether the REDD+ strategy options are effective or not. Thus the table links each of the main anthropogenic drivers of deforestation and separately of degradation, with a monitoring activity and in turn with a feedback response to the REDD+ strategy.	Item completed.

Note: During the due diligence phase prior to Grant Agreement signature, the World Bank will engage in screening of specific technical aspects and the budget, leading to a final Assessment Note. The World Bank expects that the R-PP will be used as a live document.
