#### **OVERVIEW**

#### **Overall Assessments**

#### **Grant Objectives:**

The objective of the Nepal Readiness Preparation Program is to prepare Nepal to engage in and benefit from the potentially emerging performance-based system from Reducing Emissions from Deforestation and Forest Degradation (REDD plus) within the context of the international climate negotiations of the UN Framework Convention on Climate Change.

### Overall progress from 07/01/2016 to 06/30/2017 with regard to Achieving Grant Objectives:

#### Comment:

Nepal submitted its Readiness Package to the Forest Carbon Partnership Facility (FCPF) for endorsement by the Participants Committee in September 2016. This approval paved the way for Nepal to advance the preparation of its Emission Reduction Program Document (ER-PD) under the Carbon Fund. Nepal intends to implement the Emission Reduction Program in the 12 districts of Terai Arc Landscape. The ERPD was submitted to FCPF for technical assessment. REDD Implementation Center (REDD IC) organized the first meeting of the REDD Apex Body # a high level multi-sectoral, multi-stakeholder coordination and monitoring committee on REDD+. Several capacity building and awareness raising activities were also conducted. REDD IC submitted National Forest Reference Level (FRL) to the UNFCCC in January 2017 for its technical assessment. Preparation of Investment Plan under Forest Investment Program is almost completed.

# Overall progress from 07/01/2016 to 06/30/2017 with regard to Implementation of Grant Financed Activities: Comment:

The REDD IC made good progress on preparing the ERPD, National Forest Reference Level and Capacity building, but will need to pick up the pace on the other planned activities and hire additional supporting staff. Overall disbursement has been rather slow. In the current pace, it is unlikely to use all the allocated grant within the project period.

### Grant follow-up and structure

#### Description and context of Grant:

This additional grant in the amount of US\$5,200,000 complements Nepal#s REDD+ Readiness Preparation Support Program (P125198). Activities under the original Readiness Preparation Grant of US\$3.4 million were satisfactorily completed. However, additional gaps were identified in stakeholders# understanding and capacity to effectively participate in the REDD+ process; capacity of the Government to carry out measurement, reporting, and verification of carbon sequestration in Nepal#s forests. The Additional funding will also help the Client build capacity to undertake a subnational-level emission reduction (ER) program.

Expected follow up (if any): Expanded capacity

#### Comment on follow up:

The Task Team will closely monitor the implementation of the grant and provide the necessary implementation support that the client may need. The Task Team committed to more frequent missions and technical support.

The Task Team will follow up on the repeated requests to enhance the capacity of the REDD IC and to speed up project implementation. The project will be closely coordinated with the implementation of the Forest Investment and Emission Reduction (ER) Program activities.

Component 1. Readiness Coordination and Consultation

Subcomponent 1a: National REDD+ Management Arrangements: REDD Working Group has been made more inclusively by adding representatives from related civil society organizations (i.e Association of Collaborative Forest Users Nepal (ACOFUN), Himalayan Grassroots Women's Natural Resource Management Association HIMWANTI, Federation Of Forest Based Industry and

Trade (FenFIT), and Rastriya Dalit Network (RDN). There are now 16 members in the REDD Working Group representing wide range of stakeholders. Initially, there were 12 members.

Subcomponent 1b: Stakeholder Consultation and Participation: REDD IC organized a series of grass root level consultations, focus group discussions and national level consultations on the ERPD, which is currently being reviewed by FCPF. REDD IC also conducted six Training # of #Trainers (ToT) of five days long, involving mid level REDD+ facilitators of 12 ER Program districts from June to July 2017. A total of 114 participated in the trainings (65% from civil society organizations, 35% from government agencies; 32% female). REDD IC also updated REDD+ ToT manual developed in 2014, by incorporating recent information and

Component 2. National REDD+ Strategy Preparation

Subcomponent 2a: Assessment of Land-Use, Land-Use Change Drivers, Forest Law, Policy and Governance. No progress has been made during this reporting period. REDD Implementation Center will prepareTORs to undertake studies under component 2a.

Subcomponent 2b: REDD+ Strategy Options: Draft National REDD+ Strategy is in the process of endorsement by the government. Subcomponent 2c: Implementation Framework Development: Nepal's new Constitution (2015), Forest Policy (2015), Forestry Sector Strategy (2016) and 2016 amendment to Forest Act (1993) all have incorporated forest carbon as one of the provisions.

These reforms have been very important milestones for REDD+ readiness and its implementation in the country.

Subcomponent 2d: Strategic Environmental and Social Assessment: REDD IC has started examining likely social and environmental safeguards issues of the proposed ER-Programs, and preparing SESA and ESMF for the ER Program.

Component 3. Reference Scenario Formulation and National Forest Monitoring

Subcomponent 3a: Reference Emissions Level/Reference Levels: REDD IC submitted National Forest Reference Level (FRL) to the UNFCCC in January 2017 for its technical assessment . The submitted FRL was built on the draft FRL developed during first phase of REDD+ Readiness Grant. The FRL is under technical assessment of the UNFCCC.

Subcomponent 3b: National Forest Monitoring System is being planned

Component 4: Project Management: Two government officers at the level of under secretary have been added to the existing team. REDD IC has hired procurement management and financial management consultants and have procured necessary goods (printers, papers and other supplies).

Two government officers at the level of under secretary have been added to the existing team. REDD IC has hired procurement management and financial management consultants.

# 4. Describe progress in addressing social and environmental issues (including safeguards) related to the Grant. Is the SESA conducted in accordance with the Common Approach?

Nepal prepared a Strategic Environmental and Social Assessment (SESA) to address emerging REDD+ social and environmental issues in accordance with the common approach.

The SESA and ESMF preparation took place prior to having REDD+ strategy in place. The outcomes of the study are integrated into the Nepal REDD+ Strategy. Both SESA and ESMF will need to be updated to take into account the specificities of the ER program (namely the interventions that will take place in the 12 districts of the Terai Arc landscape)

Nepal also developed the REDD+ Social and Environmental Standards (SES), viewing it as complementary to SESA/ESMF. The SES articulates country-specific needs for safeguard information systems in addition to World Bank safeguards requirements, developing a foundation for what could be shared under UNFCCC requirements, and for providing information to national and international stakeholders on non-carbon benefit, benefit sharing and governance. The English and Nepali versions of Nepal specific REDD+ SES are available at www.redd-standards.org and www.mofsc-redd.gov.np.
