FPIC Guidelines and Pilots

- FPIC Guidelines are now undergoing final review by UN-REDD agencies
- Planned launch of the Guidelines: mid-January 2013
- Now want to work with you and countries to design **FPIC pilots** to test out and implement the Guidelines --- to build on the lessons learned from previous FPIC pilot activities in Viet Nam and Indonesia

• One planned activity: 1 ½ day <u>regional Latin America & Caribbean training</u> <u>workshop in Peru</u> in late January 2013 for UN-REDD, government, IP and CSO participation on the UN-REDD FPIC Guidelines, to share experiences on FPIC and consultation, and to draft next steps on FPIC for each participating country.



National-level Grievance Mechanisms

OGRAMM

- Building on joint R-PP template, we are developing a FCPF/UN-REDD Guidance Note to support countries to establish National-level Grievance Mechanisms for REDD+
- Will soon hold global and national consultations on this topic to ensure we are addressing key concerns from IPs and local communities
- Will carry out pilot activities to support countries to develop grievance mechanisms during 2013.



Community-Based REDD+ Facility

UN-RE

- UN-REDD, in partnership with UNDP-implemented Global Environment Facility Small Grants Programme (SGP) – and in consultation with FCPF -- is exploring a mechanism to deliver community-level grants for activities related to REDD+
- Responding to demand from FCPF and UN-REDD countries to expand community-based work
- <u>Objective</u>: To catalyze REDD+ readiness from the ground up, bringing resources and capacity to communities, empowering them to engage in national REDD+ activities and pilot important REDD+ methodologies and safeguards.



Community-Based REDD+ Facility: Objectives

- Activate community-based action to improve the implementation of REDD+ readiness for FCPF and UN-REDD
- Support countries to meet the Cancun safeguards and FCPP/UN-REDD Guidelines and ensure the full and effective participation of IPs and civil society in REDD+
- Improve coordination between community grants within the Biodiversity, Climate Change and Land Degradation focal areas of the SGP and national REDD+ activities under the FCPF & UN-REDD Programmes to multiply impacts
- Support learning and sharing of lessons drawn from community-based experiences in support of REDD+.

Community-Based REDD+ Facility: Activities

- Grants of up to \$50,000 directly to IP and other communities to support National Programme/R-PP or national REDD+ strategy objectives.
- Potential activities include:
 - Capacity building activities for local-level IP and community-based organizations in pilot REDD+ sites to understand REDD+
 - Reviews of national and local tenure and land rights issues by IPs and CSOs for inclusion in national R-PP documents
 - Community-led pilot activities to trial and refine REDD+ approaches for participatory forest mapping and monitoring; FPIC and benefit distribution pilots; development of sustainable livelihood alternatives; ancestral domain mapping, claims and recognition, etc.



Community-Based REDD+ Facility: Next

- Currently looking for financing for pilot phase in a few countries in 2013
- Seeking your advice on how to best to develop program so it responds to needs of Indigenous Peoples and CSOs
- Will work with FCPF and FIP to ensure this mechanism complements their grant initiatives and so we can learn together.
