Background (1)

- Previously presented Carbon Fund LTP at CF2 (Berlin, October 2011)
- Approved Carbon Fund budget for FY13 (Santa Marta, June 2012)
 - Included estimated budget for Shared Costs
 - Recommended exclusion of IP/CSO Program from Shared Costs
- Approved Readiness Fund base budget for FY13 (Santa Marta, June 2012)
 - Agreed to exclude IP/CSO Program from Shared Costs
 - Additional activities not approved (except \$200k for Capacity Building for Social Inclusion)
 - Proposal for additional activities recently submitted to PC13 meeting to be held in Brazzaville on 21/22 October with a budget for FY13 of \$1.3 million

Background (2)

- If ER Program included in pipeline, agreed to allocate a financial envelope up to \$650k (subject to a signed Letter of Intent) to develop an ER-PIN into an ER Program Document (Santa Marta, June 2012)
- Finalized actual expenditures for FY12 for both the Readiness Fund and the Carbon Fund (see Annual Report)
- Prepared LTP for Readiness Fund
 - Including Shared Costs over lifetime of fund
- Note these figures are financial projections to FY20 so they are necessarily approximations

Shared Costs

- 'Shared Costs' across both the Readiness Fund and Carbon Fund have included in practice the activities paid out of:
 - FCPF Secretariat
 - REDD Methodology Support
- Consistent with the Charter, from FY12 the Carbon Fund assumes a 35% share of these costs (65% to be covered by the Readiness Fund)
- The PC approved an overall cap of \$12 million that can be charged to the Carbon Fund for Shared Costs over the lifetime of the fund (PC8, Da Lat, March 2011)
- Based on the LTP for the Readiness Fund which assumes a steady operational budget through FY16, with 20% annual cuts thereafter


