

- 6 national workshops for strategy formulation are planned

Sub-component 2a: Assessment of Land Use, Land Use Change Drivers, Forest Law, Policy and Governance

 The study of the causes of deforestation and forest degradation is completed The study of legal and institutional framework for the implementation of REDD+ in Mozambique is completed

Sub-component 2b: REDD+ Strategy Options

- The REDD+ strategy document containing the strategy options will be presented at the Paris COP
- The strategy is incorporating the results of four studies funded with this FCPF grant

Key Achievements - Component 3: Reference Emissions Level/Reference Levels



- JICA is specifically supporting MITADER, in setting REL/RL at the subnational level, for two provinces
- Basic maps of 2008 were developed for two provinces based on high resolution imagery as well as reference year maps using medium resolution imageries

→ Additional funding is needed for the preparation of the REL/RL, and forest inventory process in the rest of the country



Key Achievements - Component 4: Monitoring Systems for Forests, and Safeguards

Sub-component 4a: National Forest Monitoring System

- The Forest Resource Information Platform is being designed to host the information of the National Forest Monitoring System
- Training was conducted regarding updating procedures for the platform content and updating procedures for map data
- JICA project is considering NFMS by combination of remote sensing and forest inventory.





Sub-component 4b: Information System for multiple benefits...


 Relevant non-carbon aspects and social and environmental safeguards are being considered as component of the study being conducted by SESA team.



Key Gaps & Challenges (1)

Support to the REDD+ Readiness Management Arrangements, communication and consultation activities

 Adoption of a legal complementary instrument for the formalization of the entire structure of UT REDD+



Need for institutionalization of the technical units of REDD+ at provincial level (UTP-REDD+)

The local forums should be enhanced and structured with representation at the district, provincial and national levels

Strengthening Mozambique's Forest Governance

The creation of a new Ministry (MITADER) opens an opportunity to the review of the forest legislation in line with REDD+ main objective





Key Gaps & Challenges (2)

Preparation of Emissions Reductions Landscape Pilot Programs

 Finalized the design of the Zambezia and the Cabo Delgado Integrated Landscape Management Programs: studies, preparation of safeguards instruments, consultations, communications, coordination of activities, team hiring, etc.)

Development of historic land covers change maps

 Additional funding is needed for the completions of the process in the remaining provinces





Key Gaps & Challenges (3)

Design and implementation of the forest inventory

 Establishment of a national forest inventory to obtain basic data for the establishment of MRV at national level until 2018;

Monitoring Systems for Forests

 Improving coordination between the institutions concerned or related to the national forest monitoring system;

Preparation of MRV

- Improvement of the appropriate mechanisms for effective sharing of information on forest monitoring system and of MRV;
- Strengthening of the institutional capacity of the pilot projects to deal with relevant aspects about other benefits (non-carbon benefits) and safeguards;


