Update on Progress since PC20

- ▶ Data collection took place between November 2015 and March 2016
- ▶ Progress reports and OC conference calls held biweekly
- ▶ Rotating Co-chairs (currently Canada and Transparency International) held calls with Evaluation Team
- ▶ Additional REDD countries nominated (Argentina and PNG)
- ▶ Reference Group provided guidance on the 1st country report
- ▶ Outreach to PC to encourage participation in feedback exercise

Zero Draft Evaluation Report

- ▶ Zero draft evaluation report for the OC received on April 14
 - ▶ Overall OC assessment of Zero Draft:
 - ▶ Data collection: Good
 - ▶ Analysis: Weak - Further work required
 - ▶ Presentation of findings: Weak - Needs work
 - ▶ External validity: Weak/Medium - But this is ok
 - ▶ OC sub-group + Reference Group met in-person in Helsinki with the Evaluation Team to discuss feedback on April 25-27

- ▶ Presentation of Findings at PC21
- ▶ Full report including conclusions and recommendations to the PC by May 19, 2016
- ▶ Feedback opportunities for PC
 - ▶ Initial reactions at this PC
 - ▶ Opportunities for discussions with Evaluation Team at this PC
 - ▶ Two week commenting period for PA and PC, May 19 to May 30, 2016
