# Background (1)

- Draft Logical Framework included and presented in FMT Note 2011-10 rev. in Berlin
  - Evolved from FMT's brainstorming on what the strategic thrust of FCPF for the next few years could potentially be
- Revised Logical framework presented in FMT Note 2012-4 in Paraguay
  - PC requested FMT to prepare a draft M&E Framework for the FCPF using relevant elements of the logical framework, and the draft framework that was prepared at the time of the first evaluation of the FCPF
  - Carbon Fund resolution CFM/3/2012/3 requested a proposal for reporting progress on Carbon Fund on semi annual basis

## Background (2)

- Draft M&E framework has been developed (Annex 1 to FMT Note 2012-11)
- Led by experts from Baastel (Alain Lafontaine) and ECO consult (Cornelia Sepp and Dietrich Busacker on behalf of GIZ)
- Framework includes:
  - Rationale and conceptual basis for monitoring and evaluation
  - Consideration of FCPF objectives and the Facility's operation to date

## Background (3)

- Framework includes (2):
  - Revised logical framework
  - Performance Measurement Framework (PMF)<sup>1</sup> with indicative targets for monitoring progress including those for the Carbon Fund
  - Format for reporting progress to the PC on semi annual basis
  - Scope and frequency of future evaluations
  - Roles and responsibilities of various stakeholders

*<sup>1</sup> The PMF is tool to be used by FMT to manage collection of data, analysis and reporting of performance data*

# PC Feedback: Key questions

- Feedback is solicited on the following:
  - Do you agree with the conceptual basis and scope of the proposed framework?
  - Are all the key results (outcomes and outputs) reflected in the framework (including for Carbon Fund activities)?
  - Are the building blocks to be used for data collection and reporting the right ones?
  - Do you agree with the number and scope of future evaluations?
  - Are the roles and responsibilities proposed for managing the framework clearly defined?
  - Is the format for semi-annual reporting by the FMT reasonable (including for Carbon Fund)?
- Next steps: Draft will be revised and finalized by PC14

# Feedback from Carbon Fund Participants

- Draft Framework presented at Carbon Fund Meeting on Oct 17,2012
- Feedback
  - Overall the conceptual basis and structure proposed for monitoring and evaluation is sound
  - Frequency of reporting progress to the PC/CF should be reconsidered ( perhaps annual instead of semi-annual?)
  - Some indicators could be more ambitious, further clarified
  - Participants expressed interest in providing written feedback
