# Background

- Task at PC16 is to discuss and recommend to the PC:
  1. which new REDD+ countries to select into the FCPF, and
  2. on what terms/modalities new countries would be supported.

- Selection criteria:



Quality of R-PP



Commitment of a Delivery Partner

- n/a – FMT has confirmed on behalf of the Working Group



Availability of sufficient resources in the Estimated Reserve



Other factors PC considers relevant

# Background

- Working Group has recommended that the PC fund new Countries on the same terms as existing REDD Country Participants (\$3.8M Readiness Preparation grant plus FMT/Delivery Partner support)
- Working Group has recommended against the possibility of a new category of un-funded observer country; while keeping the current one-time meeting observer status for non-participants.
- Funds now available to support up to eight (8) new Countries
  - Countries that are not selected will be asked to resubmit to PC17 for TAP/PC review.
