

#### Team overview




### Evaluation purpose and scope

- ◆ The **objective** of the evaluation is to assess the FCPF's progress and achievements and to identify lessons learned while providing accountability to financial contributors and other stakeholders.
- ◆ The evaluation will be **global**, covering Africa, Latin America and the Caribbean, and Asia to include the 32 countries of the Readiness Fund portfolio as well as the 15 countries of the Carbon Fund portfolio.
- ◆The evaluation will build on **prior evaluations of the FCPF** and other relevant studies and will specifically look at the FCPF's performance from 2018 to present.

# General approach

- ◆ The evaluation will follow the **OECD/DAC criteria** of relevance, coherence, efficiency, effectiveness, impact, and sustainability.
- ◆ A theory-based evaluation approach, informed by a realist evaluation approach, will be used to explore progress and outcomes at country level.
- ◆ The evaluation will also be grounded in the following **principles**: mixed methods, participation, and intersectionality.

# Theory of change analysis



#### Data collection methods

- ♦ In depth desk review
- ◆ Portfolio analysis
- ♦60 interviews with key informants at the program level
- ◆ E-survey for country-level stakeholders involved in the Readiness Fund, the Carbon Fund, and the FCPF programs
- ♦ 7 in-depth country case studies
- ♦ 9 light-touch case studies (desk-based):
  - 5 light-touch country case studies
  - 4 light-touch thematic case studies


