












## Project Contribution to Country Project Document



# Way Forward: Beyond the REDD+ Readiness Grant

- 1. With the REDD+ four pillars in place (National REDD+ Strategy and Investment Plan, National Forest Monitoring System, Forest Reference Level, and Safeguards Information System), Kenya is now in a good position to fully implement REDD+ interventions
- 2. Integration of REDD+ in the ongoing MPTF IV to ensure implementation
- 3. Commitment from the National Government and its bilateral and multilateral partners to implement REDD+ is required. UK Government through the UKPACT has prioritized REDD+
- 4. Kenya in partnership with UNDP and other bilateral partners will leverage on its capacity to build networks and partnerships to identify opportunities to support these efforts
