Proposed Activities - MRV (1)

- Country Support Additional support for the operationalization of country MRV systems.
 - Previous funding not sufficient to meet country needs
 - This support will focus on REDD countries that still have significant gaps in the operationalization of their MRV systems
- Global activities Additional Support to enabling activities for MRV country support, including dissemination/capacity building of different deliverables generated, e.g. guidance on Montecarlo simulations.

Proposed Activities - MRV (2)

- Support to the operation of the Global Forest Observation Initiative (GFOI) office
 - GFOI Office is responsible for facilitating the coordination of the different activities developed by GFOI partners including capacity building, Methodology and Guidance Document (MGD), R&D,...
 - Moreover, the GFOI office maintains and facilitates
 access to key country capacity building resources such
 as the MGD, REDDcompass, OpenMRV and the GFOI
 registry of tools.
 - Activities from the GFOI Office are all conducive to the implementation and operationalization of country MRV systems

Proposed Activities - MRV (3)

- Support to the operation of the Global Forest Observation Initiative (GFOI) office
 - Aligns with the following objective of the FCPF Charter "(a) To assist...REDD Countries in their efforts to achieve Emission Reductions.....by providing them with financial and technical assistance in building their capacity to benefit from possible future systems of positive incentives for REDD"
 - This financial support from the FCPF will serve to unlock funding from other donors to the GFOI Office
